




More students seeking tenure track jobs than jobs available

## The Big Picture: Job Market and PhD Preparation Nationally

- Decline in academic jobs
  - Focus on teaching
- Internationalization of doctoral education
- Interdisciplinary and collaborate approach to research and knowledge building which addresses social problems (Impact)
- Competencies and skills for profession and employability (Teaching, Grant Writing, Statistical Analysis, Leadership in Profession, Team work)

## PhD Career Pathways (Council on Graduate Schools)

- PhDs in non-research universities view teaching as primary responsibility
- PhDs in Research Universities view research as primary responsibility but the majority viewed teaching as either primary or secondary responsibility

## GADE Quality Guidelines and Job Market

- Teaching (educated to have a core expertise in teaching and pedagogy)
- Knowledge of the social work as a profession
- PhD Graduates are to be the **Stewards of the Social Work Discipline\_**(history, policy, social justice, values and ethics, or other areas that may distinguish PhD education and research training from other disciplines and toward the social work profession)
- Research (educated to have a core expertise in research skills; research for social work practice and not just specific to other social science disciplines)



## How Do Other Professions View Stewardship of the Discipline

- Preparing PhD nurse graduates for leadership is important for stewarding the discipline.
- Stewarding a discipline involves generation of knowledge.
- Conservation of history and fundamental ideas inherent in the discipline is important.
- Dissemination of and sharing new knowledge to broad audiences is a component of stewarding a discipline.
- The process of stewarding is unique to each PhD-prepared nurse depending on prior experiences and expertise.
- Stewarding the discipline can be done by developing policy, critiquing the status quo, and conducting research.




## Research Questions & Aims

- ✓ Examine what types of courses are offered in PhD curriculum across GADE member schools
- ✓ Assess the implementation and consistency of GADE Quality Guidelines within course offerings
- ✓ Evaluate differences and similarities that may exist based on AAUP rankings
- ✓ Evaluate approaches to Diversity, Equity, and Inclusion (DEI)

## Method: Sample

- GADE Affiliated Universities (n=85)
  - PhD Programs Only
  - 84 total programs used in curriculum analysis



## Method: Coding & Design

- Courses were double-blind coded by category\*. Verified by third and fourth coders and PhD Directors
  - 1146 courses were coded into 28 categories (i.e. Academic and Professional Development, General Theory, Research Methods, Statistics, Pedagogy, etc.)
- Universities R1, R2, R3 and other based on ranking
- GADE importance responses ranging from 1 (not influential) to 5 (extremely influential)
- 73 open-ended responses regarding DEI subjectively analyzed



## Results: Curricula Findings

#### **Teaching**

Only 66% offered courses in teaching or pedagogy

#### **History and Social Work Profession and Theory**

- Only 23.8% offered courses focusing specifically on social work history and professional development.
- Only 57% offered a course in Policy
- Only 7% offered a course on diversity
- Programs offered an average 1 course in theory
- Less than 20% offering courses in micro, mezzo or macro theories

#### Research

- Programs offered a mean of 5.7 courses in research and statistics (combined)
- Only 44% offered a course dedicated to **qualitative research** (R1 and R2 = 1 course, R3 = 2 courses)
- Coursework in measurement, literature reviews and metaanalysis, program evaluation, and intervention research were offered in less than 20% of PhD Programs

 Of 67 respondents, 65 indicated that diversity, equity, and inclusion content is incorporated into their curriculum or program, either implicitly or explicitly. In addition, 11 total programs indicated that they were actively working to improve diversity, equity, and inclusion content throughout their curriculum and program.

## Take Aways for Doctoral Curricula

- Preparation for Teaching and to be Stewards of the Social Work Profession is Essential
- Research Focused on Knowledge and Interventions that Benefit Social Work Practice
- PhD Programs Need to Embrace and Follow GADE Quality Guidelines
